## A Letter from the President...

Spring is nearly here, and I'm sure everyone is busy planning their garden. The Spring Luncheon is coming up and it promises to be very interesting. The drawing for the Motawi raffle tile takes place at the Spring Luncheon. A new board will be stepping up to the plate also, and I'm sure they will do a good job in the coming year. And remember, if you renew your dues on time, you are eligible to win a \$50 gift certificate.

Last year the Club learned that we were required to pay sales taxes on the items being sold to support the Scholarship Fund. The board decided the tax money should come out of the gross sales receipts. In the process of looking at this as well as our tax exempt status (we are a 501 (c)(7) organization) and the regulations concerning that status, we also learned that a certain percentage of our income must come from our members. It appeared at first glance that the income from the scholarship sales may have been reaching a point where they might be generating more income from non members than what we were allowed to earn. To determine if we were in compliance with Federal Tax Regulations, we hired a consulting firm that specializes in Non Profit Organizations to determine if it may have been necessary to change our tax status.

After reviewing the consultant's report, the board decided a change of tax status was not required, as we were compliant with the Tax Regulations. We must be careful, however, when we host the Big 10 Conference in two years, as this may strain those regulations. Also changing our tax status might have meant changing the purpose of the club, and the board was not interested in doing that at this time. If you have any questions about this process, please contact me.

I have enjoyed my year as President and hope to remain an active member for many years to come. Thank you for the privilege of serving you.






