Memorandum of Understanding
between
The Illinois Club and OLLI at Illinois

This Memorandum of Understanding (MOU) sets the terms and understanding related to the affiliation between The Illinois Club and OLLI at Illinois.

Goals: The goals of this affiliation:

- Strengthen both organizations by supporting each other's membership efforts;
- Enhance the experiences of the members of both organizations by providing opportunities for shared social events;
- Support each other's promotional initiatives.

OLLI at Illinois will

- Provide a 10% discount on the annual membership fee to all current members of the Illinois Club (beginning with the 2027 fiscal year);
- Open a minimum of three (3) social events per year to members of The Illinois Club;
- Acknowledge The Illinois Club as an Affiliate of OLLI at Illinois on its website and share Illinois Club information through social media and other platforms.

The Illinois Club will

- Provide a 10% discount on the annual membership fee to all current members of OLLI at Illinois (beginning with the 2027 fiscal year);
- Open a minimum of three (3) social events per year to members of OLLI at Illinois;
- Acknowledge OLLI at Illinois as an Affiliate of The Illinois Club on its website and share OLLI at Illinois information through social media and other platforms.

Duration:

This MOU is at-will and may be modified by mutual consent of authorized representatives from The Illinois Club and OLLI at Illinois. This MOU shall become effective upon signature by the authorized representatives from The Illinois Club and OLLI at Illinois and will remain in effect, unless or until it is modified or terminated by any one of the partners by mutual consent.
